Salary	Outreach and partnership manager, .025 FTE to oversee project staff, data and evaluation and monitor budget.		
Salary	Conservation Coordinator, .40 FTE to manage recruitment, organize speaker trainings, and coordinate Neighborhood Events. Recruit and oversee volunteers.		
Fringe Benefits	Fringe benefits are a percentage of salaries and include FICA, unemployment insurance, worker's compensation, retirement and health insurance. Outreach manager estimated at 12% and Conservation coordinator estimated at 28%.		
Services	Contract for the I Love Boise! Community program; a two day community building workshop in Foothills Conservation. We have applied to the Dept. of Parks and Recreation to be one of the projects they work with in the next year. There was an application and interview process and they have indicated that our program is a great fit if we can find the resources. They are ready to book foothills conservation field trips with us. Their customary fee is \$10,000 plus travel. We will source the funds from this request and other fundraising dollars. Three biologists work with 20 high school students and educators in this two day experience.		
Services	As part of the partnership with Parks and Rec, we will need to cover the travel for our trainers to see other foothills conservation sites and programs. The estimated travel expenses are: airfare (\$500), lodging (\$300), per diem (\$120) which equals \$920 x 3 conservationists totals \$2760.		
Educator Training	Coordinator will hold training sessions for new and existing participants, may involve stipend for the trainer.		
Neighbor Event Supplies	Includes flyers and program printing, props if needed and light refreshments.
